

BCRSP General Meeting Minutes

BCRSP December Meeting December 13, 2023

President Danny Stribling called the meeting to order at 11:30 a.m. Chaplain Betty Munion offered the invocation and led members in the United States and Texas pledges.

TRT Foundation- Danny Stribling reported a total of \$540 was raised for the foundation.

Legislative- Dr. James Warner reported the 6 lawsuits filed against accepting the amendments from the November election were thrown out due to lack of evidence, and also they were filed after the deadline date. TRTA and TRF will now start working on legislation that will include all retired school personnel on a permanent COLA.

Program- Betty Munion, who provided the Christmas table decorations, explained their history. She also led members in several Christmas songs. Keagan Owen, the Bryan High School student soloist, was ill and could not attend.

Children's Book Project- Mary Ann Gaylord and Sandra Petty encouraged members to donate either books or monies toward the project. Suggestions of places to drop off books for Christmas were also requested. Books may be donated through February.

Membership- 1st VP Frances Maloney thanked members for joining. A total of 349 members were reported.

Volunteer Hours- Patsy Bolch requested the total hours be sent to her by December 31.

Door Prizes- Lynn Blinka drew tickets for the Christmas themed door prizes. **Other Business**

Legislative Update - January 2024

COLA -

TRS plans to mail individual statements to all COLA-eligible annuitants beginning January 22. Statements will include exact deposit amounts (less withholding) and planned deposits dates.

ACTUARIAL SUMMARY OF ANNUITY FUND -

The statement of the financial health of our annuity fund has been completed and released for review. You may read the report in its entirety (all 80+ pages) at TRS PUBLICATIONS.

In short scary, out fund amount stood at approximately \$182 billion as of 9/30/2023. The return on investments for FY 2023 was 3.8%. This compares to -6.7% for FY 2022 and approximately 26% for FY 2021. The assumed rate of return on investments is 7.0%.

We are fortunate that funds for the earlier supplemental checks and the upcoming COLA will come from the budget surplus rather than from the annuity fund. The monthly cost of the regular annuities is approximately \$1.1 billion.

MARCH PRIMARY ELECTIONS -

The Primary Elections for both Texas political parties are scheduled for March 5. It is essential that education retirees vote in these elections. Usually less than 10% of Texas voters decide who the candidates will be in November. Several of our strongest supporters will be in hotly contested races. Other of our supporters have either retired or decided not to run again. Watch this space for candidates, statements, etc.

TRTA PLANS OF 89TH TEXAS LEGISLATIVE SESSION -

No decisions have been solidified yet, but discussion centers around encouraging the 89th Texas Legislature to present a united front to the Texas Congressional delegation to do away with both the WEP and the GPO. Also, under discussion is finding a way to standardize COLAs so that everyone benefits and there is not another 20-year lapse between COLAs.

VOLUNTEER ROURS

Dear Members,

Hard to believe but another year has left us. I will need your yearly total by the end of January. You can email them to me or feel free to call me. You time runs from Jan. 1- Dec. 31, 2024.

I had someone ask why volunteer hours were so important. They are important because **NUMBERS COUNT...IT PAYS** in public relations with taxpayers (saves them money) and the most important reason of them all is with **LEGISLATORS** when the value of education retirees volunteerism is considered during legislative negotiations (this concerns our pension and insurance).

Here are some guidelines for you:

- •The state will only allow 12 hours per day if you are the sole caretaker of a loved one you can claim these hours.
- •Other types of community services are: schools, libraries, small businesses and business office (assist or provide bookkeeping, fill out Medicare forms or insurance forms for the sick or elderly, including your parents), hospitals and nursing homes (visiting the sick, working in the gift shop, personal care), friends and neighbors (mow lawns, clean houses, visitation, run errands, babysit grandkids), church (sing in the choir, bell choir, teach Sunday school) raising money for a worthy cause (organize raffles or sale, assist with crafts and bake goods) and calling on friends, neighbors and family to see how they are doing.

These are just a few services. If you aren't sure if what you volunteered for is acceptable please call me or email and I will let you know.

Remember no time is too little. Your time begins the minute you start your car and ends when you return home including any prep time at home.
